Complete and email this form to your Business Services Center (BSC) division team (FBSO Directory) at least 2 weeks prior to domestic travel and 4 weeks prior to international travel. International travel must also be registered with OGE here in order to be fully approved. This request form allows BSC to submit a TA on your behalf in the financial system; it does not serve as the TA itself. Please ensure all members of BSC are added as delegates on your profile to allow submission (instructions here). TAs cannot be approved in the financial system once travel has begun; submit requests early!

It is fine to leave a field blank if you aren't sure of the answer or if the field does not pertain to you. Travel Authorizations are required for out-of-state travel even if you don't expect to be reimbursed; in that case list \$.01 in the estimated trip expenses section.
